

**ORDINANCE NO. 17-1096**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF BLACK DIAMOND, KING COUNTY, WASHINGTON, AMENDING THE BUDGET FOR CALENDAR YEAR 2017 AS ADOPTED BY ORDINANCE 16-1083 and 17-1088 for MEANS OF APPROPRIATIONS, ADJUSTMENTS AND TRANSFERS WITHIN VARIOUS FUNDS IN ACCOUNTS IN THE 2017 BUDGET**

**WHEREAS**, RCW 35A.33.120(4) allows budget amendments to be authorized by ordinance for funds received in excess of estimated Revenues during the fiscal year if those amounts exceed the amounts set forth in Ordinance No. 16-1083 and 17-1088; and

**WHEREAS**, it is necessary to make adjustments to those accounts and/or funds by means of appropriation adjustments and transfers to the 2017 Budget;

**WHEREAS**, it is also necessary to utilize \$68,000 of the \$886,818,291 General Fund Unreserved Ending Fund Balance to cover the 2017 anticipated \$210,000 cost of the OPMA Lawsuit that is not covered by excess sales tax revenue,

**NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF BLACK DIAMOND, KING COUNTY, WASHINGTON, DO ORDAIN AS FOLLOWS:**


**Section 1.** Section 3 of Ordinance 16-1083 is hereby amended with the following additions:


**Section 2.** This Ordinance shall be in full force and effect five days after its passage, approval, posting and publication in summary form as provided by law.
