A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF

DECLARING CERTAIN CITY PROPERTY SURPLUS TO
THE NEEDS OF THE CITY

Section 2. City Council authorizes staff to make items available for sale either by sealed bid, online auction or other reasonable and allowable means.
