A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BLACK DIAMOND, KING COUNTY. WASHINGTON **AUTHORIZING** AN **AMENDMENT EXTENDING** INTERLOCAL AGREEMENT WITH THE CITY COVINGTON AND MAPLE VALLEY THAT ESTABLISHES PROCESS AND PROCEDURES FOR JOINT PUBLIC WORKS **OPERATIONS COOPERATIVE** AND PURCHASING.

WHEREAS, in June of 2011, the parties entered into an Interlocal Agreement between the Cities of Maple Valley, Covington and Black Diamond for Joint Public Works Operations and Cooperative Purchasing, which had an expiration date of December 31, 2015; and

WHEREAS, in February and March of 2012, the parties entered into the First Amendment to the Interlocal Agreement between the cities of Maple Valley, Covington and Black Diamond which retained the original expiration date of December 31, 2015; and

WHEREAS, in January 2016, the parties entered into a Second Amendment to the Interlocal Agreement, extending the agreement for another five years, through December 31, 2020; and

WHEREAS, the parties wish to extend the agreement for another five years; and

WHEREAS, the City expects the cities of Covington and Maple Valley to approve the Interlocal Agreement extension in the form attached hereto;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BLACK DIAMOND, WASHINGTON, DOES RESOLVE AS FOLLOWS:

<u>Section 1</u>. The Mayor is hereby authorized to execute the Third Amendment to the Interlocal Agreement Between the Cities of Maple Valley, Covington and Black Diamond for Joint Public Works Operations and Cooperative Purchasing, extending it through December 31, 2025, in a substantially similar form to the one attached hereto.

All other provisions of the Agreement shall remain in full force and effect.
