Once the backflow assembly has been installed, call 360-886-5717 for a Public Works inspection. Once Public Works signs off your installation, you need to have it inspected and tested by a certified backflow inspector. You have 15 days to complete this inspection and return test results. If this matter goes unattended, the City will start notifications and process to shut off water service to the property.

Please provide a copy to the City of Black Diamond (reference the permit number) for final sign-off of your permit.

Whereas the City may need to protect your home and the City's water system from crossconnection contamination from the irrigation system being installed, the City will need the authority and right to enter the property, shut off, and lock the valve to the irrigation system without shutting off the potable water to your house. By signing this permit, you are giving the City access rights to your property for the purpose of isolating the irrigation system from the residential water service and the City's public water system. The City will unlock the valve to the irrigation system once the check valve is serviced and tests show proper function.
